We have agreed to indemnify Ladenburg against liabilities, including liabilities under the Securities Act of 1933.

USE OF PROCEEDS

The net proceeds to us from this sale will be approximately \$3,880,000. We plan to use the net proceeds for general corporate purposes, including:
