

PROSPECTUS SUPPLEMENT
(TO PROSPECTUS DATED APRIL 12, 2000)

COMMON STOCK

APA OPTICS, INC.

You should read this prospectus supplement and the accompanying prospectus carefully before you invest. Both documents contain information you should consider when making your investment decision.

PLAN OF DISTRIBUTION

Pursuant to this prospectus supplement, we are offering an aggregate of 217,688 shares of our common stock to Amro International, S.A. and Roseworth Group Ltd., institutional investors, through Ladenburg Thalmann & Co., Inc. The common stock will be purchased at a negotiated aggregate purchase price of \$4,000,000. We will pay Ladenburg a commission of \$120,000 on this sale. We have agreed to indemnify Ladenburg against liabilities, including liabilities under the Securities Act of 1933.

USE OF PROCEEDS

The net proceeds to us from this sale will be approximately \$3,880,000. We plan to use the net proceeds for general corporate purposes, including:

- * Expansion of production facilities
- * Product development
- * Sales and marketing of our DWDM-based product line
- * Working capital
- * Hiring new personnel
- * Acquisition of complementary businesses, although no businesses have been identified at the present time

MARKET FOR OUR COMMON STOCK

On July 18, 2000, the last reported sales price of our common shares on the Nasdaq SmallCap Market was \$21.25 per share. Our common stock is listed on the Nasdaq SmallCap Market under the symbol "APAT."

As of July 18, 2000 and before the issuance of shares pursuant to this prospectus supplement, we have 11,676,172 shares of common stock outstanding.
